UPON hearing the counsel the Court made the following O R D E R

- 1. Heard learned counsel for various parties at a considerable length.
- 2. The appellants are permitted to file their respective rejoinder affidavits within four weeks. They will also be at liberty to file their response to the proposals.
- 3. The Union Bank of India is permitted to place on record amended counter affidavit or additional affidavit, as the case may be.
- 4. Those respondents, who have not filed their counter affidavits so far, are granted liberty to do so within four weeks.

- 5. The intervention applications filed by the home-buyers/land-owners/lenders/financial institutions/banks are allowed. They are permitted to assist this Court. If they so desire, a common counter affidavit may be filed.
- 6. The office of Mr. Nakul Dewan, learned Senior Counsel representing the Interim Resolution Professional (IRP) shall prepare a convenience compilation for and on behalf of all the parties and the same shall be circulated between the parties one week before the date fixed.
- 7. The interim directions issued from time to time shall continue till further orders.
- 8. List on 13.08.2025, at 11.00 A.M.
