## Supertech Limited - Details of designated Escrow/Collection Account for each project

Supertech Limited was admitted into Corporate Insolvency Resolution Process ('CIRP') by an order dated March 25, 2022 ("Insolvency Admission Order"), passed by National Company Law Tribunal, New Delhi Bench VI ("NCLT") in C.P. (IB) No. 204 of 2021 filed by the Union Bank of India. By the same Insolvency Admission Order, the NCLT appointed Mr. Hitesh Goel as the IRP of the Corporate Debtor.

The NCLT order was later challenged by one of the directors of the suspended Board of the Corporate Debtor before the Hon'ble National Company Law Appellate Tribunal ('NCLAT'), wherein vide an order dated June 10, 2022 ('Appeal Order'), the Hon'ble NCLAT passed an interim order that all other projects of the Corporate Debtor apart from the Eco-Village 2 Project shall be kept as an ongoing project. The construction of all other projects shall continue with the overall supervision of the Interim Resolution Professional ('IRP') with the assistance of the ex-management and its employees and workmen.

Further, in order to ensure proper management of funds, the RP/IRP has allocated a specific collection account for each project. Customers are urged to deposit their dues solely into the designated account corresponding to the given project.
